Holders of NQS or FAUI certification or CMAS qualifications issued in another country

Include 2 recent clear passport style and size colour photos with the signature of the applicant on the back of one.

- Pay the applicable fee.
- Sign the declaration at the bottom of the page.
- Provide clear photocopies of your NQS, FAUI or CMAS qualifications/certificates, as well as any other dive certification you have obtained since this certification;
- Provide a copy of a current dive medical certificate (completed within 90 days); and
- evidence of recent diving activity (log book or statutory declaration).

Renewing AUF-CMAS Diver level applications (if hold a current AUF issued CMAS 1, 2, 3 or 4 Star CMAS Diver certification card)

- Include 2 recent clear passport style and size colour photos with the signature of the applicant on the back of one.
- Pay the applicable fee.
- Sign the declaration at the bottom of the page.

As you can no doubt appreciate SCUBA diving is a skilled recreation and as such, we must be careful with replacement of expired certification cards so If your AUF-CMAS certification expired more than 6 months ago you may be required to meet additional requirements. Please contact the National Recreational Diving Commissioner prior to completing this form for details of requirements.

Once assessed we will send you your AUF-CMAS card, if you qualify. If your application is not successful, your payment will be refunded.
